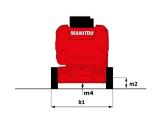
Load chart

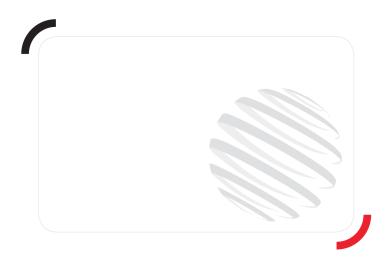
